The SSRA Extraordinary General Meeting was called to pass three (3) items:

- 1. Adoption of the New Constitution
- 2. Exemption of five (5) clubs from the citizenship requirements contained in Article 8.6 of the New Constitution, namely: (i) The American Club; (ii) The British Club; (iii) Hollandse Club; (iv) Singapore Cricket Club; and (v) Tanglin Club
- 3. Postponement of the 2022 Annual General Meeting to February 2024 and extending the tenure of the current Board until the Annual General Meeting is held.

The current Constitution requires at least 25% of the total number of Members (Individual and Organisation Members) entitled to vote or thirty (30) Members (Individual and Organisation Members) entitled to vote, whichever is lesser, present at a General Meeting to form a quorum. Honorary Secretary Mr Raymond Tan confirmed that a quorum was present the Chairman declared the Extraordinary General Meeting ("E**GM**") open and welcomed the Members present

- The postponement of the 2022 Annual General Meeting (AGM) to February 2024 and the extension of the tenure of the current Board until the AGM is held
 - Upon passing the New, NGP Constitution, time will be needed for Registrar of Societies (ROS) to approve the New, NGP Constitution.
 - Hence, a motion to postpone the AGM to February 2024, as well as extend the tenure of the current Board until the AGM is held was put forward to the members present.
